Patricia related David became highly irritated with Richard (yelling in Richard's direction). Patricia related David advised Richard he was not going to stop filming the meeting. Patricia related she does not know how the physical altercation began but observed the two men on one of the tables (located on the north side of the banquet hall room. Patricia related she observed Richard with a facial injury after the two men disengaged.
